## Register a donor as a new user with credit card checkout

Donors can register as a new user when they make a credit card donation via a donation form or eCard part. This functionality was previously removed from the checkout flow; this service pack restores the original functionality.

This update helps organizations acquire users as intended, ensures consistency across donation methods, reduces potential confusion for new users, and ensures seamless integration with a donor's checkout experience.

## Password requirements

With this service pack, we've update password requirements to match Central Authentication Service (CAS) 2025 standards.

Previously, user passwords:

- couldn't include references to a time, date, or season,
- couldn't include a backwards (reverse string) version of their name or the organization's name,
- and had to change every 90 days.

Those restrictions no longer apply. Relaxing password requirements reduces potential ambiguity and frustration for users.

However, user still can't create passwords with:

- their user name,
- first name,
- last name,
- organization name,
- "password" (case-insensitive),
- or "Blackbaud" (case-insensitive).

## MatchFinder Online

Previously, if an organization had **MatchFinder Online** active and matching gifts were enabled for a donation part, then a link to **Look it up** appeared after the **My company will match my gift** checkbox. When donors selected the link, **MatchFinder Online** appeared and enabled donors to search for a company.

**MatchFinder Online** was retired. Therefore, we've removed the **Look it up** link from all user interfaces in **Blackbaud NetCommunity**.

The **Look it up** link was removed from:

- Donation forms (classic)
- Ecards
- Event classic
- Membership
- Donation forms 2.0
- TestConfig and ConfigInfo
- Matching gifts in ***The Raiser's Edge***

## reCAPTCHA

With this release, reCAPTCHA now appears on free registrations and events (both with and without Payment 2.0). This includes:

- Event classic,
- Membership,
- and Event 2.0.

However, reCAPTCHA won't appear for recurring donations with a future date, since they use a different transaction screen.

This improves security and especially increases resistance to automated scripting attempts ("bot" attacks).

## jQuery data table update

We updated the library for jQuery DataTables from version 1.12.1 to version 2.3.3.

The Honeycomb report uses this to show details for emails. This update ensures **Blackbaud NetCommunity** benefits from the latest features, performance improvements, and security updates.

## Bug fixes

- Previously, a server's timeout error prevented some membership transactions from flowing into the plug-in for **Blackbaud NetCommunity**. The transactions remained in the **Validation failed** state instead of **Charged**. Thus, the corresponding acknowledgment emails were not automatically sent to donors.

This is fixed. Now, if a timeout error occurs for the server, the back end process handles the transactions later. Thus the transactions flow into the plug-in for **Blackbaud NetCommunity** and are marked as **Completed**. Acknowledgment emails are automatically sent to donors as expected.

- Previously, an error message sometimes appeared when a user attempted to submit a membership plan via a **Blackbaud NetCommunity** membership form part. The error message stated, "There was an error while performing the operation. The page will be refreshed." This issue

only occurred if a user attempted to set up a membership with an installment plan, an end date more than 365 days in the future, and a credit card as the payment method. It didn't affect direct debit transactions.

With this service pack, the error message was updated to provide additional information to help users troubleshoot the issue. It now states, "The payment schedule exceeds the membership term. Please adjust the schedule to complete payments before the membership expires on mm/dd/yyyy." This error message will appear whenever the number of installments exceeds the membership's end date.

## Remember my login

In a previous release, the functionality of the **Remember** login option was removed. However, the button remained.

As of this update, the **Remember me** or **Remember login** options no longer appear on any login screen for **Blackbaud NetCommunity**.

Since this button didn't function, removing it reduces clutter and potential confusion for users.

## Single Sign On (SSO)

With [Service Pack 10](#), Single Sign-On (SSO) authentication for **Blackbaud NetCommunity** was deprecated. Organizations who already had it enabled could continue using it. However, organizations could not enable new SSOs.

The SSO capability is now disabled for all organizations. Existing SSO configurations are now also disabled for all organizations.

## Tiny MCE upgrade

With this release, we've upgraded *TinyMCE* from version 6.8.5 to version 7.9.0.

This ensures **Blackbaud NetCommunity** uses the most advanced version of the WYSIWYG editor.

## Bug fixes

- Previously, when a **Donation form** had eCards enabled and the user selected **Send me a copy of each email**, then an issue prevented the eCard recipients from receiving their eCards.

This is fixed. The sender and recipient now both receive eCards and emails as expected.

## eReceipts for Payment 2.0 Donation Forms

With this release admin users can now configure **Donation Forms** with **Payments 2.0** to show **eReceipts** to donors, including for:

- **eCards**
- **Transaction Manager**
- and **Giving Search**.

Consider updating your forms to use **eReceipts**:

1. Edit a donation form.
2. Under **Payment setup**, select **Use payment part**. Configure the part, including a combined confirmation and acknowledgment message.

You can insert merge fields and use the format options to compose the message for the receipt.

With this update, we've added additional merge fields for **eReceipts**. These include

- begin section
- number
- download URL
- end section

3. Select **Next**.
4. Under **eReceipt Options**, determine when which payment methods (credit or debit card) should generate an **eReceipts** and whether to they should be marked as receipted in the ***Raiser's Edge***.
5. Under **eReceipt Content**, insert merge fields and use the format options to compose a message for the receipt. You'll likely include a heading with donor info, a greeting, a message thanking the donor, and information about the donation.
6. Select **Preview PDF** to review the content.
7. When ready, select **Save**.

The **eReceipts** number and download URL (link) are also now included in the **Receipt Grid** merge field. Select **Language** to update the text that appears on the user interface. This now includes items for **eReceipts**:

- **eReceipts** link column header
- **eReceipts** link not applicable message
- **eReceipts** not applicable message
- **eReceipts** number column header

## Password requirements

This release enhances security with updated password requirements for all users.

Passwords must include at least:

- twelve characters
- one uppercase letter
- one lower case letter
- one number
- one special character (such as \$, #, %, \*)

Passwords can't include:

- your name (in any text direction)
- your username (in any text direction)
- "Password" (in any text direction)
- "Blackbaud" (in any text direction)
- your organization name (in any text direction)
- a year starting with 19 or 20 (even in reverse order)
- any indicator of time, date, or season (in any text direction)
- any of the above including special character variations.

For example, these don't meet the new requirements:

- P@\$w0rd
- drowssap
- My0rg1976
- My0rg6791
- Spring
- \$pring
- Spr1ng
- Sunday
- \$unday
- Sund@y

## Tiny MCE upgrade

With this release, we've upgraded *TinyMCE* to version 6.8.5.

This ensures **Blackbaud NetCommunity** uses the most advanced version of the WYSIWYG editor.

## API cleanup

APIs related to payment methods which are not **Blackbaud Checkout** were removed from **Blackbaud Net Community**.

## Bug fixes

- Previously, if a user began to complete a membership form, reached the payment step, selected **Empty cart**, returned to an earlier part of the form, added items to the card, and then attempted to pay, an error occurred.  
This is fixed. Users can now proceed to Payment 2.0 as expected, even if they previously emptied and then refilled their cart.
- Previously, when an individual used a membership form to submit a membership via pledge installments on a credit card, then the card was charged at the time of the submission, rather than the date of the scheduled pledge installment.  
This is fixed. The credit card is now charged on the date of the scheduled pledge installment, as expected.
- Previously, if an organization still used older donation forms (not 2.0), updated them to use **Blackbaud Checkout**, and also still used **Giving search**, then an error occurred when they attempted to search.

This is fixed. The search error no longer occurs. Users can make donations with **Blackbaud Checkout** as expected, even by **Giving search** form.

- Previously, from a Donation Form Part with **Blackbaud Checkout**, if a user entered an **Email address** and a **Confirm email address** that didn't match, no error occurred. Users could proceed to submit the donation, even though the email address wasn't confirmed with an exact match.

This is fixed. When the emails don't match, an error now occurs and prevents the user from submitting a donation. Users should resolve the issue by correcting the email addresses to match and then attempting to submit the donation.

- Previously, an error occurred intermittently and caused an organization to receive multiple notification emails about a transaction for a membership purchase. The membership table also showed multiple transactions. However, the transaction was only processed a single time in **Blackbaud Merchant services (BBMS)**. The duplicates appeared with the default supervisor's user ID.

This is fixed. The transactions no longer appear duplicated in the membership table and no longer generate duplicate notification emails.

- Previously, if a donation form (with **Blackbaud Checkout**) only offered pledge installments, an error caused the pledge to have zero installments, regardless of the number and frequency selected. Thus the total amount pledged was charged instead. Additionally, since the number of installments is a required field, the pledge couldn't be downloaded with the plug-in for the **Raiser's Edge**.

This is fixed. The installments and frequency are retained and respected, so that the total amount is no longer charged up front. The transaction can be downloaded with the plug-in for the **Raiser's Edge**.

- Previously, when an organization edited a **User Login** part and updated the **Language for Forgotten Username or Password**, an error prevented those changes from appearing to end users.

This is fixed. The updated labels for the user interface text now appear as expected.

- Previously, an issue caused donors to be prompted to log in to view the PDFs of their eReceipts, even if they had not logged in to make the donation. Additionally, the donation table indicated that the donations were recorded by a supervisor user after business hours, even though they'd been made by donors during business hours.

This is fixed. If a user didn't log in to make a donation, then they're no longer prompted to login to view their eReceipt. The donation is also logged with the correct time stamp and user in the donation table

- Previously, if a new user registered using *Google* for Single Sign On (SSO), via the plug-in for the **Raiser's Edge**, and **Profile Discovery** was disabled, then an intermittent issue caused some registrations for new users to receive the last name "You" instead of the name they entered. This was caused by *Jainrain API*, which *Google's* SSO uses.

This is fixed. When **Profile Discovery** is disabled, **FirstName** and **LastName** will appear blank on the registration form; the end user can enter this information into the interface.

- Previously, if a Donation Form part enabled donors to create a recurring gift at a specific frequency and didn't enable donors to specify an end date, then donors received an error message when they attempted to donate using a credit card. The error message indicated the credit card number

was invalid, even though it was valid.

This is fixed. Donors can successfully complete the transactions as expected.

## jQuery UI upgrade

With this release, we've upgraded *jQuery UI* to version 1.14.0. This ensures the latest user interface enhancements for **Blackbaud NetCommunity**.

## File and image uploads

When you upload files or images, additional text appears in the user interface to provide guidance for an optimal user experience.

- Please limit file uploads to no more than 5 at a time.
- Please limit image uploads to no more than 5 at a time.

## Session timeout after 15 minutes

If a non-admin user is inactive for 15 minutes, their session will expire. When they attempt to take action after this expiration, they'll be automatically redirected to the login page. We've reduced the session time out from 24 hours to 15 minutes for increased security.

Similarly, the **Remember me** function remains disabled for all users due to security reasons.

## Existing transaction parts require Blackbaud Checkout

As of this release, all existing payment transactional parts require **Blackbaud Checkout**. **Blackbaud Checkout** is now the only payment work flow supported. Previously, it was only required for new transaction parts.

The **Direct to payment** option is no longer available nor supported.

Forms which are configured to use merchant accounts that are incompatible with **Blackbaud Checkout** or forms configured to use **Direct to payment** no longer function. Update your existing forms to use merchant accounts that support **Blackbaud Checkout**.

Existing pages that haven't yet been updated to use **Blackbaud Checkout** and only have the credit card option selected for payment then page will warn the user that, "This page can not accept payments. Please contact your site administrator." Admin users can customize this warning message. To do so, go to **Administration, Site & Settings**, and edit the **Message for unsupported payment workflows**.

Additionally, existing pages which haven't been updated to use **Blackbaud Checkout** but offer other payment options (such as Direct Debit or Bill Me Later) alongside credit cards will continue to function without the credit card option.

A banner message will appear to remind admin users of this update. To hide the message permanently, select **Never show again**. Otherwise, the reminder will appear for each new browser session.

## Payment and payment summary parts are retired

As of this release, the following parts are now retired. These parts are no longer supported and can no longer be used to create new payments.

- Payment part
- Payment summary part



## Payment options removed from common form

**Note:** The change described below was rolled back in Hot Fix 1. For details, see [Hot Fix - Enable payments on common forms](#).

New and existing common forms no longer include the payment tab. Related merged fields no longer appear on common forms. Data for merge fields related to payments and payment information can no longer be exported for existing common forms. When you view the **Form Display** for a page, the payment step no longer appears. Payment related merge fields also no longer appear in the default confirmation.

However, users can still **Resume** existing transactions using the **Form Display** page. They can also **Edit** and **Complete** any transactions that have already been added to their cart as **Payment pending**.

## Secure payment template update was removed

The setting used to manually refresh the templates for payment 2.0 parts no longer appear when you select **Administration, Sites & Settings, Schedules**. This **Update templates** setting is no longer necessary.

Organizations now use **Blackbaud Checkout** instead. This helps ensure compliance with the **Payment Card Industry Data Security Standard (PCI DSS)**.

## Fundraiser synchronization scheduler was removed

Settings used to schedule how often the fundraiser part was synchronized no longer appear when you select **Administration, Sites & Settings, Schedules**.

These settings are no longer necessary. The fundraiser parts were retired in previous service packs.

## New Features 7.2 Service Pack 15 Hot Fix

With this update, [a change that was originally made as part of service pack 15](#) has been rolled back. Previously, payment capabilities were removed from common forms in **Blackbaud NetCommunity**.

Now, organizations can enable users to make payments via Payment pages (Payment 2.0). However, the **Proceed direct to payment** option has been removed.

1. Log in to **NetCommunity**.
2. Select **Site Explorer** and then **Forms**.
3. Find the form and select **Edit** (pencil icon).
4. Select the **Payment** tab.

5. Choose **Charge fee with form**.
6. For **Fee amounts**, select **Add form fee**.
7. Then enter the
  - display name,
  - amount,
  - and criteria.
8. Select **Save**.

**Note:** To add more fees, select **Add form fee**, enter the required details, and save again.

9. Scroll down. Under **Payment setup**, select **Use payment part** and then choose **Payment page**.  
If the menu doesn't show any payment pages, [set up a new Payment 2.0 page](#).
10. Review and configure any additional optional payment options:
  - **Bill me later** - enables user to complete form and submit no payment information.
  - **Allow users to waive the fee** - enables user to enter a waiver code (or "promo code") that you configure to bypass payment
11. Select **Save**.

If your organization processes through the **Blackbaud Payment Services** with one of the payment gateways mentioned above, you must update your *Blackbaud* solution to process through **Blackbaud Merchant Services** as soon as possible.

## New transaction parts require Blackbaud Checkout

All new transaction parts must use **Blackbaud Checkout** as their payment method. Other merchant accounts are not supported as payment methods for new parts.

If you create a new transaction part, page, or template by copying an existing one, then it must also use **Blackbaud Checkout**. If it doesn't use **Blackbaud Checkout**, then it can't be copied to make a new version.

Likewise, to copy a site, all of the site's transactional parts must also use **Blackbaud Checkout**.

Existing transaction parts remain unaffected for service pack 14 and thus they currently support both **Blackbaud Checkout** and other merchant accounts.

However, this is the last service pack that will support other merchant accounts. To upgrade to future service pack 15, you must use only **Blackbaud Checkout**.


Therefore, we recommend you update existing parts, pages, and templates or else replace them with new ones that use **Blackbaud Checkout**.

## Optimized payment workflow for checkout functionality in Ecard part

Service pack 14 enhances the payment workflow for checkout functionality in **e-Card** parts. It's now similar to checkout for donation forms.

When you edit an existing part, you can enable the enhanced workflow, by selecting **Use Checkout** on the **Proceed directly to payment** tab when you setup payment methods. If unselected, your **e-Cards**

will remain unchanged. For new parts, the option to **Use Checkout** won't appear because all new parts will automatically use the new checkout workflow.



You can also process *Direct to Payment (DTP)* transactions via the same page.

When a transaction fails, the business process now attempts to repair the transaction's current state. If the **e-Card** page is sent via an email job or message, this transaction data appears in the honeycomb report.

The **e-Card** now also shows a message indicating that the transaction is being processed, before the confirmation page appears.

Additionally, authorized donation transactions which are pending but weren't immediately downloaded using *Blackbaud Checkout* are now also repaired by the *Process CMS Transaction Business Process*. This business process runs approximately every 15 minutes. It also completes post-transaction activities, including sending acknowledgments and updating the honeycomb report.

## Optimized payment workflow for checkout functionality in event registration forms (classic)

Service pack 14 enhances the payment workflow for checkout functionality in **Event Registration Form (Classic)** parts. It's now similar to checkout for donation forms.

When you edit an existing part, you can enable the enhanced workflow, by selecting **Use Checkout** on the **Proceed directly to payment** tab when you setup payment methods. If unselected, your **Event Registration Form (Classic)** parts will remain unchanged. For new parts, the option to **Use Checkout** won't appear because all new parts will automatically use the new checkout workflow.

## Changes in documents part

By default, new document parts are not automatically granted the **Everyone** permission.

When an admin creates a new documents part, they must assign at least one user or role with permission to view it.

If you assign the **Everyone** permission, then any document uploaded via this part will be publicly accessible (not secured).

To restrict the contents of the document, assign the appropriate permissions to only specific users and role. Do so from the **Targeting and security** tab.

With service pack 14, a confirmation message now appears and warns the admin whenever they grant the **Everyone** permission.

## Bug fixes

- This update fixes an issue with donation forms in **Blackbaud NetCommunity**. Previously, when user tried to make a future recurring gift transaction from a donation form page with payment 2.0 as the payment method, then the gift amount in **Blackbaud Raiser's Edge** would show 0.00. This is fixed; now the expected gift amount appears in **Blackbaud Raiser's Edge**.

## View user's last login date, time, and browser

With this release, you can use new merge fields to view additional user information.

Find the new fields in the category for **Login history**.

- **Last login date & time**
- **Last login browser**

These show the user's data for the previous 10 login sessions. They only appear on the **Profile display** part.

You can review this history as part of your best practices for security. If the history shows an instance of a login that the user doesn't recognize, then the user's credential may be vulnerable to an unauthorized user. The user should immediately change their password and then investigate the suspicious activity further.

## More security to recover a forgotten password

As part of our ongoing commitment to ensuring security, we now require users to enter additional information when they attempt to recover a forgotten password.

Users should enter their email address and one additional data value, such as their username. Alternatively, users can enter their email address, plus their first and last name.

Once verified, they'll receive an email that includes a link to reset their password.

Users who can't provide the necessary information to verify their identity can't "self-serve" their forgotten passwords. They must contact their administrator for assistance.

## Email status removed as column in user grid

When you view the **Users** grid, the column for **Email status** no longer appears. This reduces potential confusion.

Previously this column indicated whether a user's email address was

- missing,
- verification pending,
- or verified.

Since multi-factor authentication (MFA) is no longer based on user email addresses, this column became unnecessary.

Instead, users use an authenticator app with time-based one-time passwords (TOPT).

## jQuery upgrade

## Multi-Factor Authentication (MFA) for Admin and Organization Users

If your organization is hosted by **Blackbaud**, then we will require individuals who are admins, employees, or other internal organization users to use multi-factor authentication (MFA) to log in to **Blackbaud NetCommunity**. This requirement only affects internal BBNC website users who manage your organization's website.

Donors, alums, and other external non-organization users are exempt and are not required to use MFA. Standard Blackbaud NetCommunity® website users are not currently required to use MFA at this time. Their login experience remains unchanged.

**Note:** Organizations who are on-premise and already use MFA will be automatically enrolled in this updated version. If you previously enabled it, you likely used site settings to do so. Please setup the authenticator app after you upgrade to service pack 12.

**Note:** Organizations who are on-premise and have not previously enabled MFA enforcement should contact **Blackbaud** to request this be enabled for their admin users. Previously, they would have used site settings to enable it.

When MFA is enforced for a user and they attempt to log in, a Time-Based One Time Password (TOTP) is sent to their authenticator application. This is a 6-digit code, refreshed every 30 seconds.

To view the code, you must have the authenticator application installed on your smartphone. The smartphone does not need to be connected to the Internet.

1. Download and install your mobile authenticator app. We recommend:
  - Google Authenticator for [Google Android](#) or [Apple iOS](#)
  - Twilio Authy for [Google Android](#) or [Apple iOS](#)

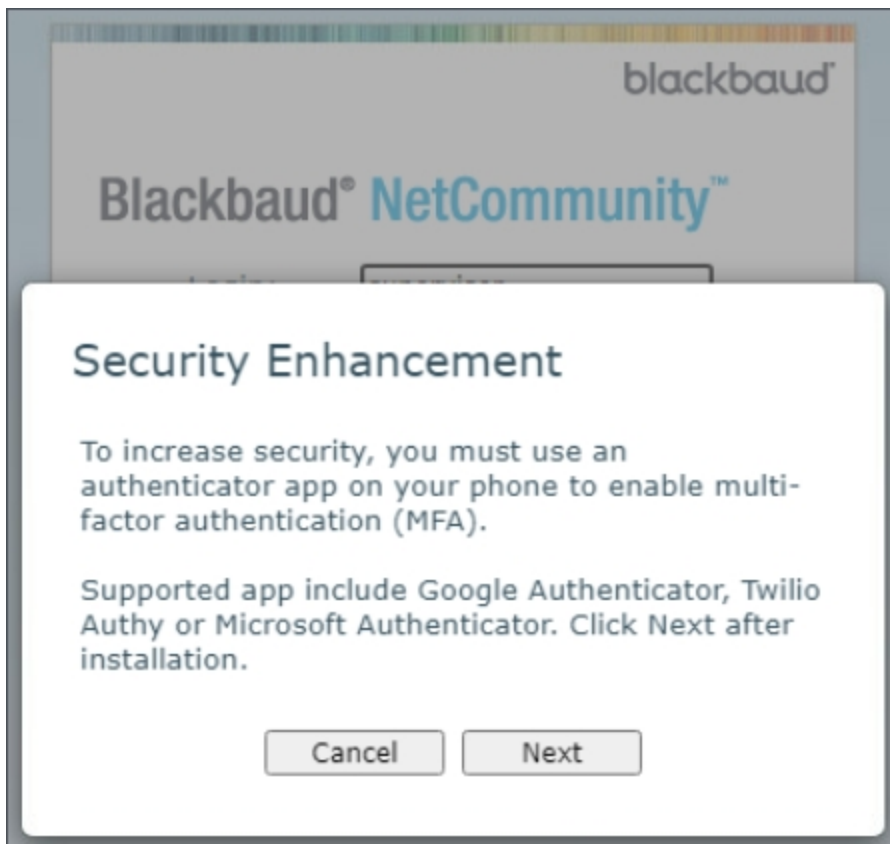



You'll still be logged out due to inactivity, however you won't be automatically redirected to login page. Thus, you'll still appear to be logged into **Blackbaud NetCommunity (BBNC)** until you refresh the browser session.

For security purposes, we therefore recommend you:

- check your internet browser settings to ensure your cookies and cache will be automatically cleared whenever you exit the browser.
- manually log out of **Blackbaud NetCommunity** whenever you complete your tasks.
- do not remain logged in with an open and active browser session when you are away from your device.

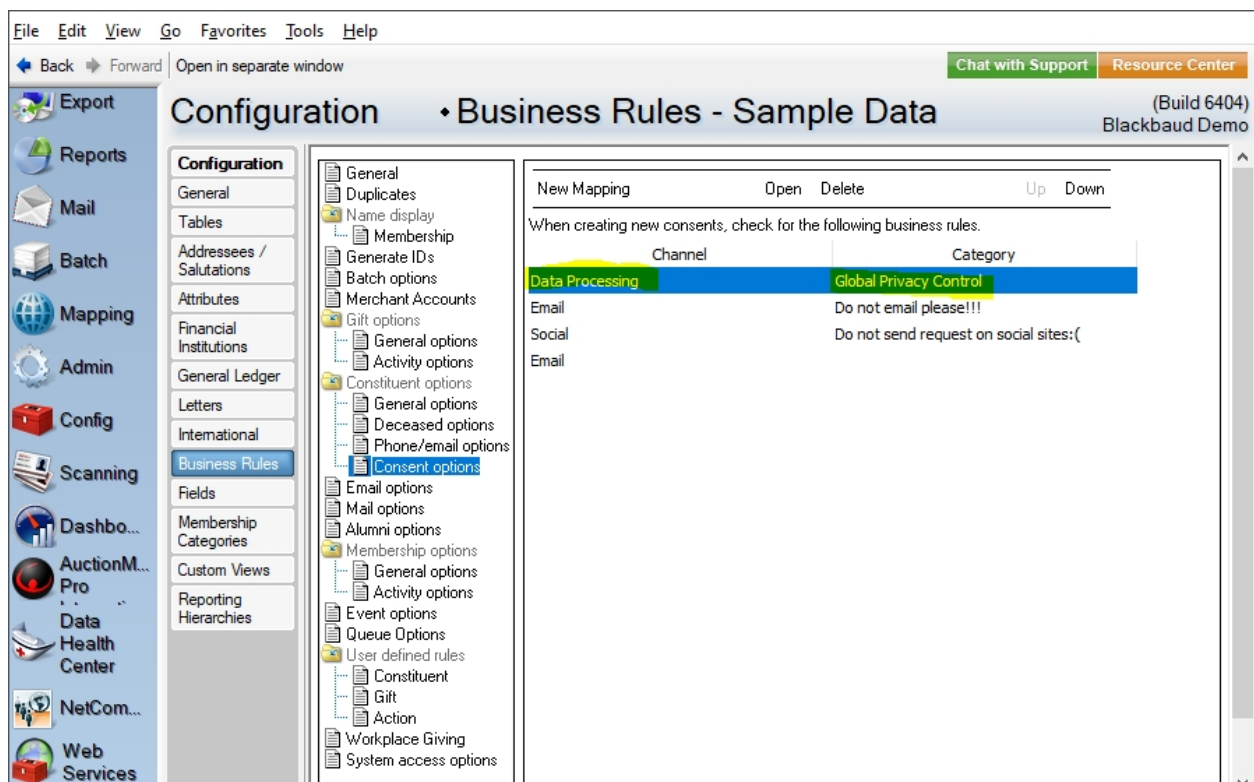

## Recognize Global Privacy Opt Out Signals

To record a **Global Privacy Control (GPC)** opt-out indicator on a constituent record in **Blackbaud NetCommunity**, you must create a GPC consent option in **Raiser's Edge** with the "Data Processing" channel and "Global Privacy Control" category.



If this consent option isn't present, or if it is present but the "Global Privacy Control" category is inactive, then GPC opt-out indicator won't be recorded on the constituent record.

Once an enabled GPC is recorded for a constituent it can't be changed. Consult your legal counsel to find out how your organization should respond to enabled GPC signals.

Use cases:

1. If a user signs up for **BBNC** who has GPC enabled, the **GPC Consent** option with opt-out response will be recorded upon constituent creation.
2. Upon **BBNC** login, for the unlinked constituent users, the **GPC Enabled** column (Yes/No) will be added to **User Gallery**.
3. If a **BBNC** website user (as logged-in linked constituent) has GPC enabled, the GPC consent option with opt-out response will be recorded upon **BBNC** login.
4. If a website user (not logged in) has GPC enabled and is making a transaction, this will lead to the creation of (or matching to) a constituent record in **RE**, and the GPC consent option with opt-out response will be recorded.
5. If a constituent already has response opt-out for the **GPC Consent** option in their consent record, has **GPC Enabled** in the browser, and does a transaction, the **GPC Consent** option with the response "opt-out" won't be duplicated on the constituent's consent records.
6. **Consent Options** with the channel "Data Processing" and category "Global Privacy Control" won't be available on the **BBNC** consent parts (both new and existing).

7. The **User** grid includes a new field called **GPC Enabled**. It shows the status of each user's **Global Privacy Control** option.
- For a Website user, the value for the **GPC Enabled** field is "NO" by default. After the **BBNC** user logs in into **BBNC** application from a **GPC Enabled** internet browser, then the value for **GPC Enabled** will become "YES."
  - For a **Raiser's Edge** Linked user, the value for the **GPC Enabled** field is blank by default and will remain blank.

You can also select to **Filter** the grid based on **GPC Enabled** status; use the checkbox above the grid to only show users with **GPC Enabled** ("Yes").

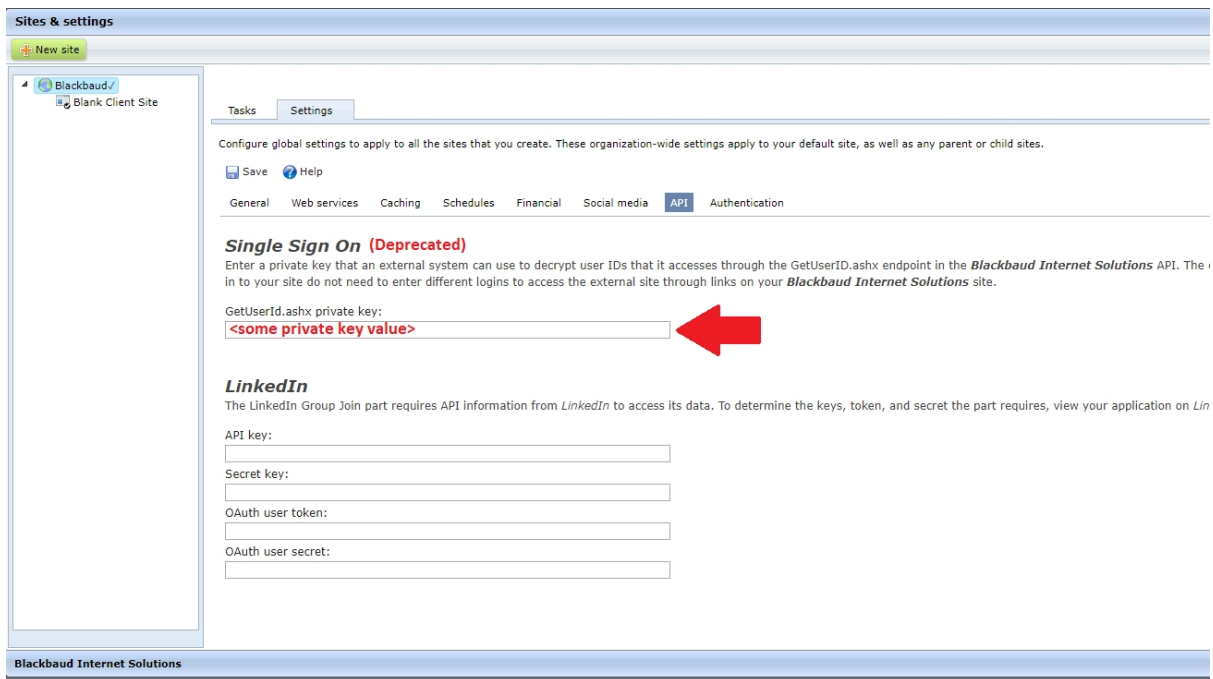



This process runs every 15 minutes to make repairs and perform all post-transaction activities, such as acknowledgements, the honeycomb update, and notifications.

## Transaction Manager Checkout and Payment Optimization

Users of the **Transaction Manager** page can make their outstanding pledge payments using **Checkout** when the **Checkout** supported **Donation Classic** page is configured in the **Transaction Manager** part.

When configuring settings in the **Transaction Manager** part, ensure of the following:

- The **Checkout** Payment option is present in the **Donation Classic** page when added in the **Transaction Manager** part.
- **Donation Classic** functionality with **Checkout Payments** is working as expected much like Direct to Payment (DTP).
- The previous functionality for the DTP method for **Donation Classic** is operating normally.
- **Checkout** is optimized via the **BBCheckout** form and has the same functionality as **Donation2.0 Checkout**, for dealing with the missed transactions related to the **Checkout** popup. Now, states are maintained in the database for a transaction flow. An existing business process was used for repairing missed transactions related to **One-time gift**. As part of this fix:
  - Missing transactions are successfully repaired.
  - The **Temporary Confirmation** screen loads after the **Checkout** popup closes and the theme matches.
- After **Missing transactions** have been repaired:
  - An acknowledgement email is sent to the donor.
  - A notification email is sent to configured roles (if applicable).
  - An eCard email is sent to configured (if applicable).
  - eReceipts are sent to the donor.

- A transaction reference number is sent in an acknowledgement email if the merge field is included in the email.
- **Donation Classic** data is reflected in **Transaction Manager** Parts.
- **Donation Classic** data is reflected in ***Blackbaud Raiser's Edge***.

## Optimized Payment Workflow for Checkout Functionality in Event 2.0

With this release, Payment Workflow functionality has been impacted and several changes have been made. The functionality works much like Donation 2.0 checkout. The state of each transaction is logged as part of this implementation. Users can view the CMSTransactions table in the database which contains entries of the correct status for each checkout transaction, review each scenario possible with Checkout transactions and check other transaction types like Bill me later.

In case of a failed transaction, the business process picks the transaction from the current state and repairs it. If the Event 2.0 page is sent via an email job / message, the transaction data will be reflected in the honeycomb report. Event 2.0 will now display a message indicating that the transaction is being processed before the confirmation page appears.

The Business Process called "Process CMS Transaction Business Process" that repairs transactions that have been authorized but were not immediately downloaded when using **Blackbaud Checkout**, has been modified to handle pending authorized membership transactions as well. This process runs every 15 minutes to make the repair and perform all post-transaction activities, such as acknowledgements, honeycomb update, and notifications.

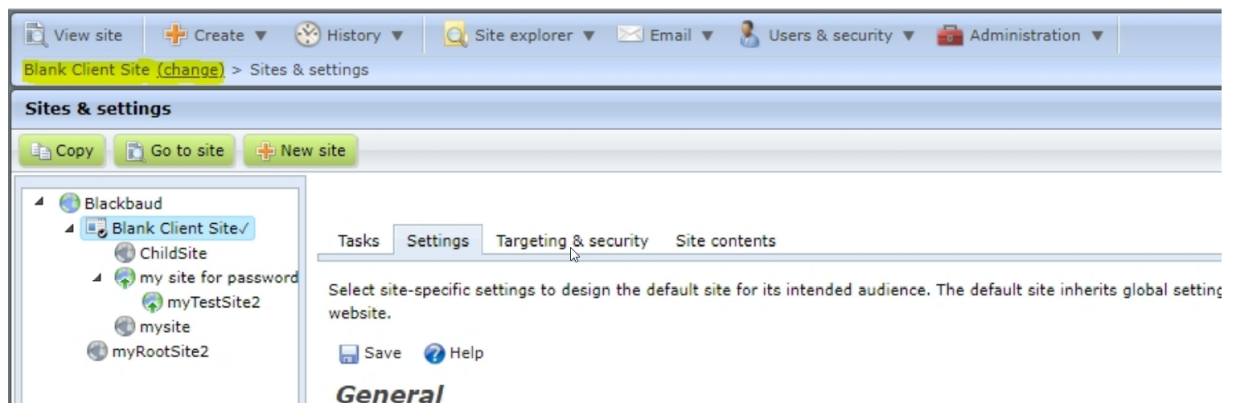

## c. Login page and email template:

- i. If no page is selected in the **Sites & Setting Member login** page for the selected site (or incoming request site), then it will use **Default site login** configuration.

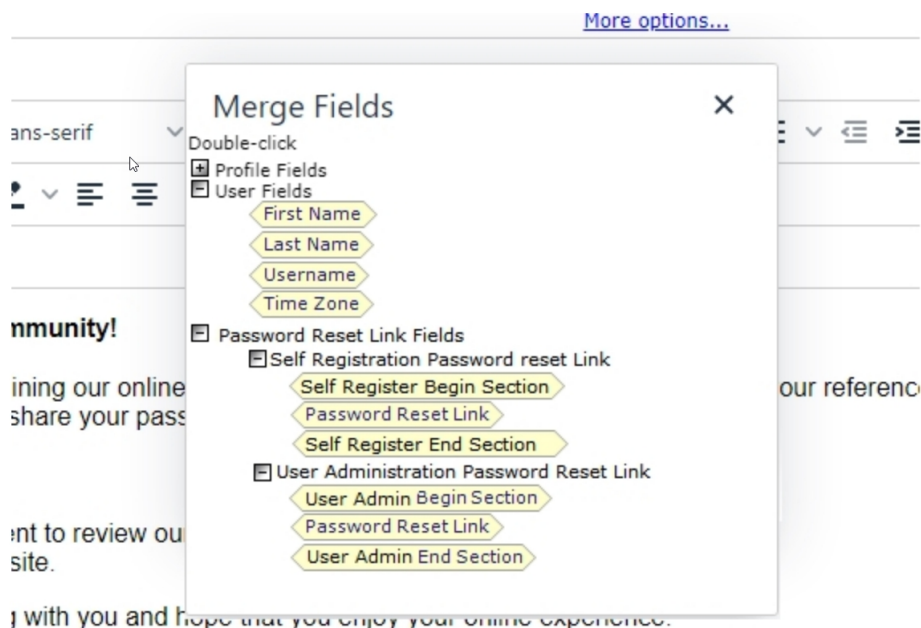


iv. The application will only be sent to the user for the raised request because the user ID is known. It will not display all users belonging to that email address, as we see in the case of password reset from the **User login** section.

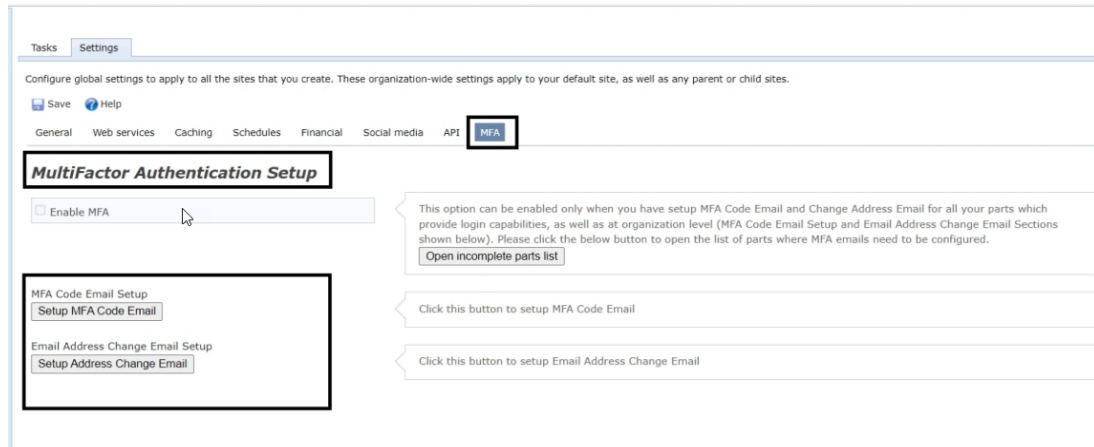

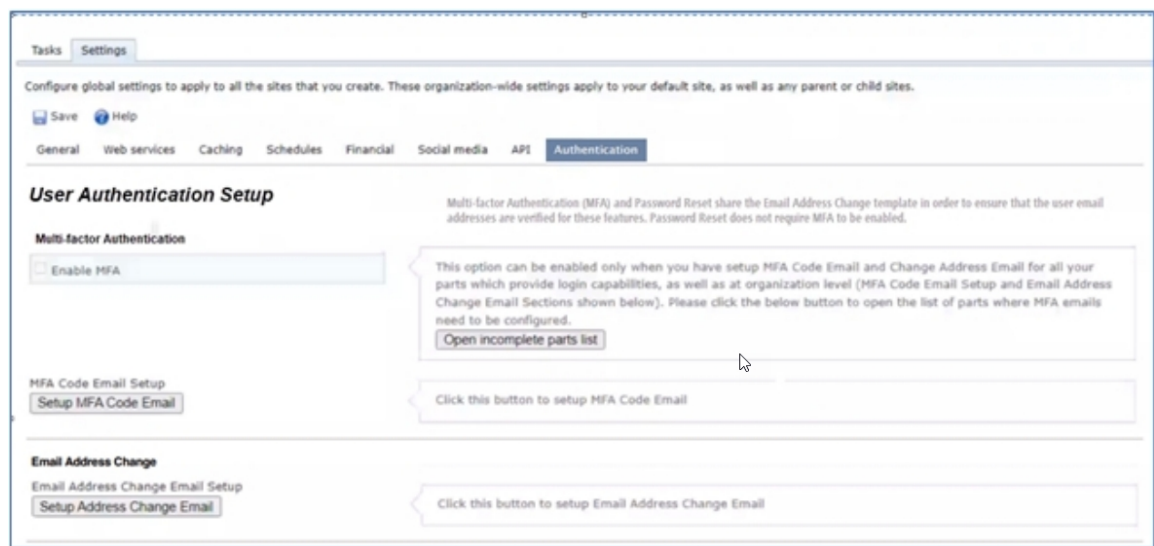

If the personal information step is not configured and the donor isn't logged in as user, then information entered in **Checkout** will be used.

## Support for Pledge Installments

The Donation 2.0 part now includes an option which administrators can enable to accept Pledge Installments as a Gift.

A pledge is a promise to pay a specified amount over a set period. Pledges are paid in one or more installments.

1. To enable this, select **All Pledge Installment gifts** when you configure the part. By default, it isn't enabled.
2. Then choose the options that will be available to donors for the frequency of their pledge installments.
  - Monthly
  - Quarterly
  - Semi-annually
  - Annually

3. Reorder the frequency options or add captions to customize how they'll appear to donors.

4. Configure the remaining settings.

These are similar to the settings available for Recurring Gifts in a Donation 2.0 part.

For example, you can determine a maximum to limit the number of installments that make up donor pledges. Otherwise, donors can enter a installment number between 1 and 99.

You'll also determine what payment methods are accepted, as well as messages for acknowledgments and confirmations.

When a donor selects to make a pledge, the donor determines the

- Total pledge amount
- Frequency of installments
- Number of installment
- Start date of the first installment

and then provides the appropriate provide credit card or direct debit information for payments.

**Note:** The "Bill me later" option is not available for pledge installments.

## Merge Fields for Direct Debit

Merge fields for **Direct Debit** are now enabled by default for use on the **Acknowledgment Email** and **Confirmation Screen**.

Previously, if you wanted those merge fields, an admin had to configure them to be available first.

## Merge Fields for Credit Card

An admin can now configure merge fields for **Credit Card** for use on the **Acknowledgment Email** and **Confirmation Screen**.

## eReceipts for Direct Debit for the United Kingdom

In a previous release, Donation 2.0 forms were updated to support **Direct Debit** for the United Kingdom. (Your organization's culture is set to UK.)

In the current service pack, **Direct Debit Receipts** are also supported when you use a Donation 2.0 form with direct debit for the United Kingdom.

A merge field for the **Direct Debit Receipt URL** can be included in the **Acknowledgment Email** and **Confirmation Screen**.

## eReceipts

Now, eReceipts are supported when you use a Donation 2.0 form for **Credit card** and **Debit card**. An admin can enable them in **Sites and Settings**.

A merge field for the eReceipt can be included in the **Acknowledgment Email** and **Confirmation Screen**.

## Tiny MCE Editor

With this release, all *Tiny MCE* editors were upgraded to version 4.9.6. You'll use these to add and edit HTML content in a "what you see is what you get" (WYSIWYG) experience.

## Blackbaud Checkout: Membership Part

This release updates the **Membership** part to use the re-factored transaction processing architecture and integrate with **Blackbaud Checkout**.

1. Edit the **Membership** part.
2. Select **Credit Card** as a payment method.
3. Checkout is disabled by default.

Select **Add Checkout** to enable it.

**Note:** Currently on a part editor, when **Checkout** is enabled and the selected merchant account supports **Checkout**, the checkout overlay will appear. However, if the selected merchant account does not support **Checkout** (ie. it uses **(IATS)** instead), then the part will use a **Blackbaud Secure Payments** page for credit card payments. If **Checkout** is disabled on the part editor, the part uses **Direct to Payment**, regardless of the selected merchant account.

# Training

The **Help** menu now includes a clickable hyperlink to **Training**. Select it to view the current curriculum available from *Blackbaud University*.



# Maintenance Changes

Blackbaud NetCommunity version 7.2 Service Pack 1 also includes these changes.

## Bug fixes

- We improved the performance of Donation 2.0 forms. Specifically, the confirmation screen now loads faster when eReceipts are not enabled.
- Previously, when a user created a Donation Form 2.0 part and attempted to edit the text on the **Language** tab, an error caused the live form to show the default text instead of the saved customized text. This is fixed; the text entered and saved on the **Language** tab now correctly appears on the live form.
- Previously, if eReceipts were enabled, donors who submitted transactions experienced a slow loading page. Some donors submitted duplicate transactions when they believed the donation was unsuccessful. This is fixed; the page loads as expected when the donor selects **Donate Now**.
- Previously, an error caused the mini donation form part to use the **Email** or **Phone Type** based on the first **Phone Type** in the **Tables** configured in ***Raiser's Edge***, instead of the type configured in the **Sites and Settings** for **Admin** in ***Blackbaud NetCommunity***. There was a workaround (*KnowledgeBase* article: 114861). This is fixed; the mini donation form part now uses the correct settings from ***Blackbaud NetCommunity***.
- Previously, if the ***Raiser's Edge*** integration was set to regularly import data, but ***Raiser Edge 7*** was down during the scheduled import time, events would briefly disappear from the **Event Calendar** in ***Blackbaud NetCommunity*** until ***Raiser Edge 7*** was restored and the integration imported data again. This is fixed; the events continue to display even when the integration can't import data because it's data source is down.
- Previously, if a user only had email rights, an error prevented the user from using any export functions (message reports, bounces, opt outs, not-sent). When the user attempted to view the **Select Export** page, the page appeared to load but the export wasn't downloaded. This is fixed; users with email rights can successfully download exports. Users with supervisor rights never experienced the error.
- Previously, when a user inserted the email sign up form part on a ***Blackbaud NetCommunity*** page, the style sheet for the part override the site style. Now, the email sign up form part displays based on the site style sheet (correct priority).
- This release updates the reCAPTCHA integration for user registration forms to strengthen resistance to spam bots.
- This release also includes multiple security fixes.

**Note:** You must use The Raiser's Edge 7.96 (with Patch 17) or higher to integrate with Blackbaud NetCommunity 7.2. For Customer Support assistance, visit Blackbaud's [website](#).

This release of **Blackbaud NetCommunity** is version 7.2.

Previous references to the 7.2 release mentioned that it would be called version 7.1 Service Pack 6. However, due to the nature of the enhancements included in this release (such as adding **Blackbaud Checkout** to various parts), this update is 7.2 instead.

## Janrain is now Akamai

*Akamai Technologies* recently acquired *Janrain* and renamed their *customer identity and access management (CIAM)* product to *Akamai Identity Cloud*.

Integration with this third-party authentication service enables your organization to manage multiple logins for your **Blackbaud NetCommunity** website and social network websites, such as *Facebook* and *Twitter*.

Existing *Janrain* integrations require no updates: the functionality and configuration for this integration has not changed. You'll simply notice the rebrand and updated website information for the company. Your original *Janrain* dashboard remains at <https://dashboard.janrain.com/>.

We're updating our help documentation to reflect the rebrand to *Akamai*. However, some documentation may continue to use the legacy name, *Janrain*.

To set up this integration, follow the directions in our documentation for *Janrain* or *Akamai*.

# Blackbaud Checkout Enhancements

## Forms

With Version 7.2, these now also use **Blackbaud Checkout**.

- Event Registration Form part
- Payment 2.0 part

## Donation 2.0 Enhancements

In this release, we've made several new enhancements to the Donation 2.0 part.

Remember that in version 7.1 Service Pack 5, the Donation Form - Mini (Beta) was renamed and is now called Donation 2.0. This form also uses **Blackbaud Checkout**.

## Support for Direct Debit(ACH)

To enable donors to contribute gifts via *Automated Clearing House (ACH)*, you can now enable **Direct Debit** when you setup payments on a donation form part.

From the part editor, select **Payment Setup** and choose whether to enable direct debit payments, credit card payments, or both payment methods. When you enable direct debit payments, donors will enter the name of the account holder, their bank name, the account number, and the routing number (or sort code) to complete the payment. Based on where the donor lives, they may be required to enter additional information.

## Support for "Other" Designations

When your organization selects to **Enable Other Designation** on a donation form, the donor can select **Other** under **Designation** and then enter which fund should receive the donation. This information also appears on the confirmation page for the donation and in acknowledgment emails.

An admin then links the donation to the appropriate fund from **Raiser's Edge** when the admin processes transactions through the **Blackbaud NetCommunity** plug-in.

Your organization can customize the caption text that appears in labels for this functionality, such as "How would you like to direct your donation?"

## Match Event Guests to Constituents in Raiser's Edge

When an individual registers to attend an event, and the primary registrant brings a guest to the event, you can now match the guest to constituent in **Raiser's Edge** when you process the event transaction in the **Blackbaud NetCommunity** plugin. Previously, you could only match the primary registrant.

When you process the event transaction, the plug-in now automatically attempts to match each guest to an existing constituent in **Raiser's Edge**. Administrators can also search for existing constituents and manually link a guest to an existing constituents.

If no existing constituents match the guest for the event, an event administrator can select to create a new constituent record in **Raiser's Edge** for the link. Alternatively, you can decline the option and not create a new constituent; the guest will be noted in the same way that the guest would have been handled before this update.

## Email Enhancements

With this update, it's easier for email recipients to unsubscribe from email messages without harming your organization's reputation for SPAM compliance.

If an email recipient uses a supported email provider and your organization's email domain is in good standing as a sender (SPAM Compliance), then an unsubscribe link appears automatically in the header of the email in the email application (such as *Google Gmail*)

When a recipient selects this link, the recipient is handled as though the user selected to globally unsubscribe from a **Blackbaud NetCommunity** communication form. This does not harm your organization's domain reputation.

# Maintenance Changes

Blackbaud NetCommunity version 7.2 also includes these changes.

## Bug fixes

- *Google Analytics* no longer generates the analytics.js "ga" code which **Blackbaud Netcommunity** needs for site tracking. Instead, *Google Analytics* only generates the gtag.js "Google Tag Manger" code by default. This default may prevent the confirmation screen from appearing on your donation forms. To resolve this issue, go to **Administration** and **Sites & settings**. Then **Edit** the site tracking code. In the first line of the code, replace the word aync with aync="true". **Save** your changes. These directions are also included in the *Blackbaud Customer Support Knowledgebase* article 114068.
- We improved the performance of Donation 2.0 forms. Specifically, the form now loads faster when it includes many countries as options in the drop down menu.
- Previously, if a user submitted a payment for an Event 2.0 part and included extra whitespace after the cardholder name, the cardholder's last name sometimes appears blank in the **Raiser's Edge** plugin. The first name still appeared as expected. This is fixed; extra spaces in the name are now handled without issue.
- Previously, an error caused eReceipts to generate blank .pdf files for a small number of organizations with **Spark**. This is fixed; the files are generated with the appropriate content for eReceipts.
- Previously, if an organization used Donation forms but didn't have the Tribble module, an error could occur. This is fixed.
- Recently, users who did not have full Supervisor rights were unable to view the "honeycomb" email report. This is fixed. Users who have access to manage emails can view the email reporting data included in this report.
- Previously, if an organization linked a Membership form to a Payment 2.0 part, and selected for the email confirmation to include membership members and additional members, an error prevented the names of the additional members from appearing in the confirmation email. This is fixed; all the names appear as expected.
- Recently, an error caused gifts to intermediate appear and disappear from scrolling donor display and fundraiser dashboard results. This is fixed; the results are consistent and correct.
- To ensure we provide the latest security enhancements for **Blackbaud Netcommunity**, we upgraded *jQuery* to version 3.4.1. We recommend that all clients upgrade apply version 7.2 to ensure they take advantage of the latest security enhancements.

## Patch 1

- Previously, when an Event 2.0 form with **Blackbaud Checkout** was used to register multiple attendees, an error caused guest names to be duplicated in the acknowledgment email sent to the

user. This is fixed.
